The Board of Finance will consider approval of the wastewater system transfer from the County at its meeting on September 15, 2015 in Santa Fe. Advice has been provided regarding the Eastlack claim against the Association. Publication of notice of the application for the third well in Picacho Hills has been completed.

Mrs. Horton mentioned that she would be out on vacation September 10-11, 2015; Mr. Fernandez will be left in charge while she is out.



# DAMDWCA Customer Service Department Report

8 September 2015

## I. Billing:

1. Billing was submitted to Go Direct on September 2, 2015. Unfortunately this was due to errors that occurred during the billing process causing a delay in the billing calculation. With the Tyler system it will notify you of any errors that can potentially create more problems in the future. In order to proceed with billing all errors must be corrected before it allows you to proceed. There were a total of 66 errors that were corrected causing the delay. This was due to manual meters not having readings, radio meters that were no longer registering, extremely high water usage, or outstanding service orders. In addition there were several idle accounts with consumption. This turned out to be accounts that did not transfer over correctly from CUSI.

## II. Penalties:

- 1. Penalties for August totaled: \$11,593.73, however the billing statements contained the incorrect address. Due to this error several customers remitted their mail payments to our physical address causing them to be returned by postal service. If the customer brings in their envelope showing they mailed their payment in time prior to the penalty day we will take that into consideration and remove the penalty applied to the account.
- 2. Penalties have been moved to September 21, 2015 due to the billing statements having been submitted late.

## III. Disconnects:

1. On August 24, 2015 we disconnected accounts for non-payment. A total of 62 accounts were up for disconnected.

## **Production Report for Month of August 2015**

## Doña Ana MDWCA System:

- 38,263,107 gallons of water pumped for the month of August and reported to the New Mexico Office of the State Engineer. (see attached sheet)
- Water Conservation Fee in the amount of \$1,147.89 was submitted for the month of August.
- Routine disinfection and bacteriological monitoring of the system were conducted throughout the month. Nine (9) samples were taken throughout the month at random alternate sites as per "Approved Sampling Plan" through New Mexico Environment Department-Drinking Water Bureau.
- Dona Ana water meters were read on 8/16/15 Re-reads also completed.
- There were 5 new water services installed within the Doña Ana MDWCA System.
- There are 4,109 water service connections within this system.
- Vehicle and Equipment maintenance were conducted throughout the month.
- Maintenance on-going on all Wells, Booster stations, and Well houses.
- Completed Lead and Copper samples. (30 samples required, every three years). Sent in to NMED approved Lab for analysis
- A Weed control in D.A. (Wells, hydrants, tank sites).
- Repaired 7 service leaks/angle valves in the D.A. service area.
- Repaired 6 inch water main break on Calle Contento. 8pm-2:30am
- Cross Town Construction completed pavement patch on Dona Ana School Rd. Inspected and approved by Dona Ana County Road Department.
- Removed all tamper proof locks off of fire hydrants at Public Schools

## PICACHO HILLS PROJECTS

## TANK @ PICACHO HILLS

Souder Miller & Associates (SMA) has received final approval from New Mexico Environmental Department Drinking Water Bureau (NMED DWB). SMA is using the information from the pump test to modify the design to upsize the booster station and include additional Pressure Reducing Valves (PRV), SMA is still in communication with the pump manufacturers to size pumps for the Anthem Booster Station and awaiting a response. SMA anticipates the design being submitted for final approval before the end of September.

## DISTRICT 5 SPECIAL USE PERMIT (SUP)/EXTRA TERRITORIAL ZONING (ETZ) Application

The signed easement and deed for the tank site has been recorded at the County along with the easement from the Village of Hatch. Souder Miller & Associates (SMA) should receive approval from Dona Ana County (DAC) for the SUP application and therefore should receive approval from the City of Las Cruces (CLC) for the ETZ Application.

## **DISTRICT 5 WASTEWATER DISCHARGE PLAN**

New Mexico Environmental Department Ground Water Quality Bureau (NMED GWQB) has approved the Wastewater Preliminary Engineering Report (PER). This will be completed and submitted to NMED-GWQB by September 4, 2015.

## **DISTRICT 5 HEADWORKS**

The Categorical Exclusion was received from Environmental Protection Agency (EPA) on August 6, 2015. Souder Miller & Associates (SMA) has contacted the low bidder Morrow Enterprises to verify they are holding their bid amount. Contractor has notified SMA that there will be an increase in cost of \$7,000 for the metal railing. SMA is awaiting confirmation that this will be the only increase in cost for the project. The contractor has indicated he can begin construction on the week of September 14 or 21, 2015 to start constructing the concrete structure.

## **District 5 Building**

Construction for the project commenced on April 6, 2015. DMJ Contractors has completed erecting the building, framing the interior and closing in the walls, building utilities, and exterior concrete work (curb, gutter, flatwork and parking pad). The majority of the project is complete. The contractor has installed the lab cabinets and is waiting for the counter tops to arrive this week. DAMDWCA has contracted Cross Town to place the gravel road. Cross Town is working on placement of base course for the gravel road and should be completed this week.

## District 5 Wastewater PER

• Preliminary Engineering Report (PER) was submitted to New Mexico Environmental Department (NMED), New Mexico Environmental Department Ground Water Quality Bureau (NMED-GWQB), and New Mexico Environmental Department Constructions Program Bureau (NMED CPB) on October 28, 2014. Comments were received from NMED CPB November 20, 2014 and NMED-GWQB August 12, 2015. Souder Miller & Associates will address both of these review agency comments and re-submit an updated Preliminary Engineering Report (PER) for review by September 18, 2015.

## PICACHO HILLS ARROYO

Staff and I walked the Arroyo taking depths through the area on the existing sewer line.
 Manholes 1-3 are the critical areas showing depths of 14.5 inches to 20.5 inches. Manholes 3-8 show depths of 3-4 feet. Research with Dona Ana MDWCA staff and Souder Miller & Associates staff is ongoing with regards to possible solutions to protect the existing sewer line that run through the arroyo. See attached map

## FAIRVIEW PROJECTS

## Fairview Water

• Construction plans and technical specifications were submitted to the following agencies: City of Las Cruces (CLC), Doña Ana County (DAC), Elephant Butte Irrigation District (EBID), International Boundary and Water Commission (IBWC), New Mexico Department of Transportation (NMDOT), New Mexico Environmental Department Constructions Program Bureau (NMED CPB) and New Mexico Environmental Department Drinking Water Bureau (NMED DWB). Project has received approval from NMED DWB, EBID, and IBWC. Souder Miller & Associates (SMA) has made modifications to the construction plans and technical specification based on review agency and Doña Ana MDWCA comments. SMA is currently working out minor modifications to address comments from Dona Ana County (DAC) and New Mexico Department of Transportation (NMDOT).
